

BAC Resolution Recommending the Use of Negotiated Propurement through the Responsive Quotation and Recommending Assertion

RESOLUTION NO. 21-0417 Series of 2021

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE, of the PROVINCIAL GO FROM BOHOL made procurement of goods under Purchase Requests No. 2021-0397; re; Procurement of Various Office Functional Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagblaran City, and ABC of P 278,923.32;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL QUALITY CORP.</u>
offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL QUALITY CORP</u>. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>BOHOL QUALITY CORP</u>, has been found to be ELIGIBLE and its bid, RESPONSIVE;

- b.) To recommend award to <u>BOHOL QUALITY CORP.</u> for the delivery of goods/services under Negotiated Canvass No. <u>2021-0260</u> in the amount of <u>P 273,527.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
