

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsible

Quotation and Recommending Approval

RESOLUTION NO. 2021- 136 Series of 2021

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u>, of the <u>PROVINCIAL</u> GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 107</u> re: <u>PROCUREMENT OF LAPTOP COMPUTER ABC of P 59,990.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>3 MSG ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>3 MSG ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>3 MSG ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>3MSG ENTERPRISES</u> in the amount of <u>FIFTY NINE THOUSAND NINE HUNDRED EIGHTY NINE PESOS AND 80/100 (P 59,989.80)</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2021 086</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
