BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 2/12/- 130 Series of 2021

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY (BOHOL CONTAINERIZED PCR LABORATORY) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 163 re: Procurement of OFFICE SUPPLIES FOR THE USE OF THE PGBh CONTAINERIZED PCR LABORATORY with an ABC of P 125,224.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AT TRADING** offered the Single price quotation as reflected in the Abstract of Bid Quotations.

- a.) To declare <u>GOLDEN AI TRADING</u> as the bidder with the <u>SINGLE CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2021 122 (Emergency Cases)</u>;
- b.) To recommend award to <u>GOLDEN AI TRADING</u> for the delivery of goods under Negotiated Canvass No. <u>2021 122</u> (<u>Emergency Cases</u>) in the amount of <u>P 123,368.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
