

BAC RESOLUTION RECOMMENDING PROCUREMENT THRU SHOPPING METHOD, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. PRDP-IR-R007-BOH-024-000-000-2018 re: PROCUREMENT OF BRAND-NEW DELIVERY TRUCK (HEAVY DUTY ALUMINUM VAN BODY TYPE) with an ABC of Php 4,000,000.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


