WHEREAS, in the detailed evaluation of bids FRUITFUL ENTERPRISES was declared as the Lowest Calculated Bid as Read and was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, FRUITFUL ENTERPRISES was recommended for disqualification due to the false Information due to wrong computation of NFCC, and no Marginal signature in Technical and Financial component in original document, copy 1 and copy 2 which is one of the grounds for disqualification;

WHEREAS, in the detailed evaluation of bids LEZAR TRADING as the Second Lowest Calculated Bid as Read was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, LEZAR TRADING met the required legal, technical and financial requirements for the said project

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by LEZAR TRADING the bidder, declared as the **SECOND LOWEST CALCULATED BID**, successfully passed the Post Qualification the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE**
