WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-1073 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the GOVERNOR'S OFFICE in undertaking Procurement Request under PR No. 2021-0236, re: Procurement of Tires for the Service Vehicle for used at Governor's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of ₱ 108,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers, as reflected in the Abstract of Bid Quotation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




