WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC
Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved
by the Honorable Governor, authorizing the use of the such Method of Procurement by the Provincial Health Office, New
Capitol Building, Cogon District, Tagbilaran City in undertaking Procurement Request under PR No. - PHO - 2021 - 135 re:
PROCUREMENT OF HAND DISINFECTANT WITH PUMP with an ABC of **P 108,500.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **VARIANCE TRADING CORPORATION** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **VARIANCE TRADING CORPORATION** has been found to be ELIGIBLE and its bid, **RESPONSIVE**;
