WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST-NUTRITION DIVISION OF the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0255; re; Procurement of Diesel for the use During the Nutrition Program. Assigned by Office of the Provincial Agriculturist-Nutrition Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 126,000.00;
