



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST-NUTRITION DIVISION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0255; re; Procurement of Diesel for the use During the Nutrition Program. Assigned by Office of the Provincial Agriculturist-Nutrition Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 126,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- b.) To recommend award to BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE for the delivery of goods/services under Negotiated Canvass No. 2021-0144 in the amount of P 125,370.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
