WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0248 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0264 re: Procurement for the Printing of Tourists Maps and Leaflets in Support to Promotion of Information and Marketing Needs of Bohol Island Aspiring Geo Park . Assigned by Bohol Environment Management Office (BEMO), Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City.. with an ABC of ₱ 75,000.00;
