BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive

Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0327; re; Procurement of Tires for the Service Vehicle Assigned under the Office of the Provincial Agriculturist, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 83,451.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>JAN SURPLUS CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
