WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2020-0953 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE BOARD MEMBER FRANS GELAINE C. GARCIA in undertaking Procurement Request under PR No. 2020-0164re: Procurement of Various Office Supplies & Devices for use at the Office of the Board Member Frans Gelaine C. Garcia, New Capitol Site, Tagbilaran City. with an ABC of \$\frac{1}{2}\$ 99,294.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE</u>
