WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-083 re: PROVISION OF MEALS, SNACKS AND ACCOMMODATION FOR THE SERIES OF PROVINCIAL PROJECT MANAGEMENT IMPLEMENTING UNIT (PPMIU) AND PTWGs MEETINGS, WORKSHOPS, QUARTERLY ASSESSMENT MEETINGS FOR THE PHILIPPINE RURAL AND DEVELOPMENT PROJECT (PRDP) with an ABC of ₱ 188, 000.00;


