WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2021 – 093 re: PROCUREMENT OF VARIOUS LABORATORY SUPPLIES FOR PGBH CONTAINERIZED PCR LABORATORY with an ABC of ₱ 781,270.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
