WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of DEXTEL TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid DEXTEL TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare DEXTEL TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 593,600.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2021 - 149;
- b.) To recommend award to DEXTEL TRADING in the amount of FIVE HUNDRED NINETY THREE THOUSAND SIX HUNDRED PESOS ONLY (P 593,600.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 149;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings




