

EAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>CLARIN COMMUNITY HOSPITAL</u>, <u>CLARIN</u>, <u>BOHOL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO – 2021 - 188</u> re: <u>PROCUREMENT OF RAPID TEST DEVICE ABC of P 85,000.00</u>;
