WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY (BOHOL CONTAINERIZED PCR LABORATORY) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 194 re: Procurement of VTM with Nasopharyngeal & Oropharyngeal Swabs FOR THE USE OF THE PGBh CONTAINERIZED PCR LABORATORY with an ABC of P 291,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


