

Bac Resolution Recommending Procurement Thru Shopping Method, Declaring Single Calculated and Responsive Quotation and Recommending Award

WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0060 re: Procurement of Tourist Transport Services (Van) to showcase Ubi products and product line, Ensure the availability of quality raw products and assess the farmers the women sector, the processors and youth of their participation in the celebration, Bohol Tourism Office (BTO), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with and ABC of P 102,000.00;

WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE offered the Single calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.


WHEREAS, pursuant to Section 52.1 of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to BOHOL AIRPORT DRIVERS AND OPERATORS TRANSPORT SERVICE COOPERATIVE for the delivery of goods/services the aforementioned request in the amount of P 100,200.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






