

BAC Resolution Recommending the Use of Negotiated Procurement through Small Lots, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS the CANDIAY COMMUNITY HOSPITAL, CANDIAY, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 076 re: PROCUREMENT OF VARIOUS OFFICE SUPPLIES with an ABC of P171,735.10;


WHEREAS canvass of prices done in the course of the Negotiated Method of Procurement showed that ST. JUDE PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of ST. JUDE PRESS MARKETING AND SUPPLIES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid ST. JUDE PRESS MARKETING AND SUPPLIES has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare ST. JUDE PRESS MARKETING AND SUPPLIES as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 171,735.10 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2021 - 073;
- b.) To recommend award to ST. JUDE PRESS MARKETING AND SUPPLIES in the amount of ONE HUNDRED SEVENTY ONE THOUSAND SEVEN HUNDRED THIRTY FIVE PESOS AND 10/100 (P 171,735.10) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 073;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings




