WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0283 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the GOVERNOR'S OFFICE in undertaking Procurement Request under PR No. 2021-0107 re: Procurement of Diesel and Unleaded Fuels for used at the Office of the Governor-ART, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of 200,000.00;
