WHEREAS, the GO-SPECIAL PROJECT SECTION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0323; re: Procurement of Automatic Thermal Scanner & Automatic Alcohol Dispenser, Ethyl Alcohol, Disinfectant to provide health and safety devices to detect human temperature in response to COVID-19 Pandemic, Assigned by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 100,000.00;




