ADIONG in undertaking Procurement Request under PR No. 2021-0310 re: Procurement of Various Office Supplies for use at the Office of the SP-Board Member Jescelo S. Adiong, Bohol Provincial Capitol, Cogon District, Tagbilaran City, with an ABC of ₱ 184,551.96;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL QUALITY CORP. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


