

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Quotation, Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 155 re: PROCUREMENT OF VARIOUS DRUGS AND MEDICINES ABC of P 156,287.50;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BYRO PHARMA offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BYRO PHARMA including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BYRO PHARMA has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


