WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-106 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **Provincial Health Office, New Capitol Building, Cogon District, Tagbilaran City** in undertaking Procurement Request under **PR No. - PHO - 2021 - 034** re: **PROCUREMENT OF MEDICINES FOR USE OF MENTAL HEALTH PROGRAM** with an ABC of **P 1,500,000.00**;



WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **PHARMACEUTICA FILIPINA DE VISAYAS** has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- To recommend award **PHARMACEUTICA FILIPINA DE VISAYAS** in the amount of **ONE MILLION FOUR HUNDRED SIXTY THREE THOUSAND SIX HUNDRED PESOS ONLY (P 1,463,600.00)**; for the Delivery of Goods under **Negotiated Canvass No. - PHO - 2021 - 065 (2<sup>nd</sup> failure of bidding)**;
