BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 121 re: INSTALLATION OF HEMODIALYSIS PLUMBING AND REPROCESSING SYSTEM AND MISCELLANEOUS WORKS with an ABC of P 594,039.08;
