

BAC Resolution Recommending the Use of Negotiated Procurement through Small Recommending Approva

WHEREAS, the <u>PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0019</u> re; <u>Procurement for Renovation and Improvement of Planting Stock Display Area for use at Provincial Economic Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of <u>P 234,862.74</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING, CONSTRUCTION.

STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
