



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0019; re; Procurement for Renovation and Improvement of Planting Stock Display Area for use at Provincial Economic Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 234,862.74;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE has been found to be ELIGIBLE and its QUOTATION, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to INABANGA DRILLING, CONSTRUCTION, STEEL FABRICATION & GENERAL MERCHANDISE for the delivery of goods/services under Negotiated Canvass No. 2021-0009 in the amount of P 234,550.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
