WHEREAS the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0173 re. Procurement of Desktop Computer Set, Laptop (with bag and mouse) and External Hard Disk for use at Provincial Economic Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 145,000.00;




