WHEREAS, the **CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021 - 154** re: **PROCUREMENT OF MEDICINES** with an ABC of **P1,268,895.00**;




