

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 265 re: PROCUREMENT OF VARIOUS MEDICAL SUPPLIES NEEDED AT CENTRAL SUPPLY ROOM with an ABC of P 649,450.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


