WHEREAS, the OFFICE OF THE GOVERNOR-SPECIAL PROJECT SECTION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0179, re: Procurement of Lights, Sound and LED Wall Rental for the Annual Celebrations, Commemorations and Events / Activities of the Provincial Government and Other VIP Functions. Assigned by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 470,000.00




