WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0286 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2021-0241 re: Procurement for Tarpaulin, Streamer, Fabric Materials, and Fiber Glass Plaque, for used of the Office of the Provincial Agriculturist, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, with an ABC of ₱ 163,220.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, CENTROID PRINTSHOP has been found to be ELIGIBLE and its bid, RESPONSIVE;
