WHEREAS, the **GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2021 – 147 re: Procurement of MEDICAL SUPPLIES** with an ABC of **P880,000.00**;
