



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0084**; re: **Procurement of Tent Rental to be used as Shed for product exhibit and other activities related to the Ubi Festival, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 991,900.00;**
