WHEREAS, the PROVINCIAL AGRICULTURIST OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-108 re: PROVISION OF CATERING SERVICES DURING THE CONDUCT OF TRAINING ON DAMAGE ASSESSMENT FOR HVCDP COMMODITIES (LIVE TRAINING) OF THE CROPS DIVISION with an ABC of ₱ 324,000.00;
