WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL SOCIAL WELFARE & DEVELOPMENT OFFICE** in undertaking Procurement Request under PR No. 2021-0457 ~~re Procurement of Well Milled Rice for use during Outreach Mission/Heart Caravan~~ Provincial Social Welfare & Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 100,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MULTI-PURPOSE COOPERATIVE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MULTI-PURPOSE COOPERATIVE** has been found to be ELIGIBLE and its quotation, RESPONSIVE;

- b). To recommend award to **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MULTI-PURPOSE COOPERATIVE** or delivery of goods/services under Negotiated Canvass No. 2021-0361 (2nd Failure) in the amount of ₱ 99,975.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


