

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value Declaration Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL TREASURY OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0380; re; Procurement of Delivery Receipts with Duplicate & Triplicate Copy, by the Provincial Treasurer's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 84,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE PRESS</u> <u>MARKETING AND SUPPLIES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>ST. - b.) To recommend award to <u>ST. JUDE PRESS MARKETING AND SUPPLIES</u> for the delivery of goods/services under Negotiated Canvass No. <u>2021-0246</u> in the amount of <u>P 83,500.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
