WHEREAS, the **PROVINCIAL TREASURY OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0380**; re; **Procurement of Delivery Receipts with Duplicate & Triplicate Copy**, by the **Provincial Treasurer's Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City**, with an ABC of **P 84,000.00**;




