WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2021-C-073 re: <u>PROVISION OF MEALS & SNACKS DURING THE NATIONAL AIDS & STI PREVENTION PROGRAM DAY</u> with an ABC of ₱ 128,375.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CASA REY FRANCIS PENSION HOUSE & RESTAURANT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
