

**BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award**

**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0352 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-066 re: BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 2<sup>nd</sup> QUARTER OF CY 2021 – C. TRAININGS/ SEMINARS/ WORKSHOPS AND CONSULTATIVE MEETING AND OTHER CAPACITY-BUILDING RELATED ACTIVITIES – OUTSIDE TAGBILARAN with an ABC of P 4, 324, 173.00;
