

BAC Resolution Declaring Single Complying and Responsive Bid and Recommending Approval

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, in the detailed evaluation of bids GOLDEN AI TRADING was declared as the Single Calculated Bid as Read for items. 1, 2, 6, 7, 8 & 9 in the amount of **P 42,444.00**.

WHEREAS, upon the conduct of post qualification by the Technical Working Group, GOLDEN AI TRADING met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by GOLDEN AI TRADING the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a.) To declare GOLDEN AI TRADING as the **SINGLE CALCULATED and RESPONSIVE BID** for items no. 1, 2, 6, 7, 8 & 9 in the amount of **P 42,444.00**, for the Procurement of **VARIOUS JANITORIAL SUPPLIES FOR USE OF THE PGBH CONTAINERIZED PCR LABORATORY** under Project Reference No.- **PHO - 2021-028 Rebidding**. While items no. 3, 4 & 5 having no quotation from the supplier are for **Negotiated mode of Procurement (2nd Failure of Bidding)**.
- b.) To recommend award to GOLDEN AI TRADING in the contract amount of **FORTY TWO THOUSAND FOUR HUNDRED FORTY FOUR PESOS ONLY (P 42,444.00)**.
