WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0321 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-068 re: BULK PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 2<sup>nd</sup> QUARTER OF CY 2021 – D. OTHER ACTIVITIES (PACKED MEAL) with an ABC of P 2, 740, 645.00;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., PANDA TEA GARDEN SUITES, INC., CASA REY FRANCIS PENSION HOUSE AND RESTAURANT and ALTA CEBU VILLAGE GARDEN RESORT, INC., have been found to be ELIGIBLE and its bid, RESPONSIVE;
