WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0382 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-067 re: BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 2nd QUARTER OF CY 2021 – C. TRAININGS/ SEMINARS/ WORKSHOPS AND CONSULTATIVE MEETINGS AND OTHER CAPACITY BUILDING RELATED ACTIVITIES – WITHIN TAGBILARAN CITY with an ABC of P 7, 801, 975.00;

To recommend award REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of P 2, 626, 480.00, PANDA TEA GARDEN SUITES in the total amount of P 2, 611, 911.00 and CASA REY FRANCIS PENSION HOUSE AND RESTAURANT in the total amount of P 2, 460, 059.00 for the delivery of Catering Services under Negotiated Canvass No. 2021-062 (2nd Failure);
