



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 166 re: PROCUREMENT OF SVOFLURANE 250MI, 100% V/V/ with an ABC of P 198,000.00;




