

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0659</u> re; <u>Procurement for the Construction of Slope Protection at Alemania-Limocon-Kabagakian-Anonang Road (Kabagakian Section), Dimiao, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.. with an ABC of <u>P 214,755.78</u>;</u>
