



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0659 re; Procurement for the Construction of Slope Protection at Alemania-Limocon-Kabagakian-Anonang Road (Kabagakian Section), Dimiao, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.. with an ABC of P 214,755.78;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that A & D CONSTRUCTION AND SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
