WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0371 re: Procurement of Various Drugs & Medicines for Senior Citizen Medical Missions of the Provincial Government of Bohol, by the Office of the Governor, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 1,975,135.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Lowest price quotation as reflected in the Abstract of Bid Quotations,
