WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-640 series of 2021 re: By Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIA in undertaking Procurement Request under PR No. 2021-0428 re: Procurement of Rabies Vaccine by the Office of the Province Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of 450.000.00;
