



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lawren Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 097</u> re: <u>PROCUREMENT</u> OF ISO 9001:2015 (YEAR III) SURVIELLANCE AUDIT with an ABC of <u>P 90,000.00</u>.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TUV</u> <u>SUD PSB PHILIPPINES INC.</u>, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,
