WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-085 re: PROVISION OF MEALS & SNACKS FOR BASIC LIFE SUPPORT TRAINING, ADVANCE CARDIOVASCULAR LIFE SUPPORT AND MID-YEAR ASSESSMENT AND OPERATIONAL PLANNING SEMINAR WORKSHOP with an ABC of ₱ 71,750.00;
